MIMUTES OF THE ANNUAL FINANCIAL SECRETARIES ASSOCATION MEETING

May 2 and 3, 2009

The annual meeting of the Louisiana Financial Secretaries Association was held in Shreveport, La at the Shreveport Convention Center on Saturday and Sunday May 2 and 3, 2009.

The meeting was called to order by president Keith Gautreau (8147) at 10:25am, with a reminder to turn off cell phones and pagers.

A motion was made by Don Guidry (1710) to dispense with the reading of the minutes, and seconded by John Nowak(13632). Presidents Report.

President Gautreau introduced the new form 100. Next was the States Conservation Form and instructions, instituted by Steve Thomas. This is designed for Grand Knights and Trustees however we must do our part for member retention. The state request this form be used for documentation. In our by laws it states that we will attempt to host a hospitality room on odd number years, the officers decided to make a \$500.00 contribution to the state hospitality room (#1210 at5 the Hilton). General Agent Scott Willis was introduced. Scott said he has north and western LA. He thanked us for what we do for our councils, stating we are the contacts. He said the reason for the new form 100 is the change in new member insurance. There are no more \$50.00 policies, the \$100.00 annuity replaces this for new members or their wives. Suggested we collect the money and send it to the general agent, or give it to the field agent. This annuity is guaranteed income, never will go below 3%. Old members must buy an annuity for \$300.00. Suggested to receive STAR COUNCIL a council needs to get one sale from associate member to insurance member for the state, this annuity is a great opportunity.

Treasurers report. Since treasurer Boneo was absent this was handled by president Goutreau, stated our balance was \$22,055.74 which includes \$550.00 for the state hospitality room and \$550.00 for the Bishop Greco Fund. We have a budget of \$10,300.00 and have spent \$2,300.00 so far however our expenses are now for our convention, we should make about \$2,000.00 this year, last year we lost about \$2,300.00. Keith asked for questions from the floor, none asked. Proposed budget for next year \$50.00 less than the year before, bumped up printing and paper, Bishop Greco fund to \$600.00 next year and help the state if needed, they pay our convention expenses so we should help them. Supreme Treasurer Jack O Reily entered the room and was given the floor. Good morning it is a pleasure to be here. I have a list of who has not signed on the web site, please use the wedsite or at least try to use it. You need to take care of the members not paying dues, get rid of them early so you still have time to recruit to make your quotas. Also have a list of 32 suspended councils in the state, gives the state 200 for our quota for new members. We need to do something to find the lost members, mostly from New Orleans area. The state will let you know when they disperse the members around. Culture of Life apologized for the way it was implemented but Culture of life needs to be done. The way things are today we are in much danger of loosing our tax status. The IRS is constantly in

our offices. If we spend \$1.00 from insurance money to do something on a campaign, we will loose tax status. At the same time we need to do something against same sex marriage, and abortion, we will continue to do things. We stopped same sex marriage and totally pro choice in California. The board of directors will recommend at the 2009 convention that we have this tax at \$2.00 per member instead of \$3.00. Yes it is a tax and you have to pay it. Thank you for your time. Thank you for letting me be here.

President Gautreau asked if anybody needed a break, if you do take it, we will continue on and get out a little early.
