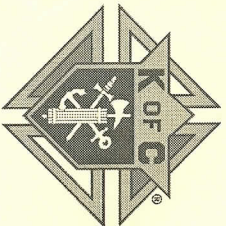

Re: **REPORT OF DECEASED MEMBERS TO MEMORIALS COMMITTEE**

At the Memorial Mass of the 1986 State Convention, the State Council initiated a new method of honoring our deceased members. Instead of reading the list of our Brother Knights who had died since the last convention, we distributed a printed booklet containing their names. Two good results were achieved: 1) a written copy of our remembrance of them became available for the respective councils to present to the families of our deceased Brothers; and 2) our Memorial Mass has been shortened, however still honoring all deceased members. This new procedure, therefore, will be continued.

To publish such a necrology will again require the close cooperation of the Financial Secretaries of the state. After discussing this procedure with the convention committee, who will do the work, we find that we must have this list in their hands by April 10. The name(s) to be included are the names of those member(s) of your council who died between April 1, 2010, and April 1, 2011, OR the name(s) of any deceased member(s) who were NOT included in last year's report. To get this listing to the printer by April 15 means **WE MUST RECEIVE YOUR REPORT NO LATER THAN APRIL 10, 2011.**

On the reverse side of this letter is the report form to use to report the name(s) of your council's deceased member(s). We suggest you fill the report and mail it NOW!!! If between that date and April 10 your council suffers any additional death(s), simply advise us in writing by April 10!!! We can then add those names to your report. Deaths that occur after April 15, 2011, but before the State Convention in 2012 are to be reported to **THAT YEARS** (2012) Convention Memorials Committee at convention.
